<p>POSITION DESCRIPTION AND DUTIES Monitors student's medical status during the school day. Provides and/or assists with medical procedures as ordered by Physician during the school day. Provides and assists student with personal care needs during the day. Notifies principal and Nursing Supervisor of changes in student's health status. Notifies principal and Nursing Supervisor of changes in individual caregiver's health status. Notifies principal and Nursing Supervisor when absences may occur to determine coverage for student. Serves as team player and role model for other employees in the organization; demonstrates a commitment to continuous quality improvement; supports and exhibits organization core values of caring, respect, integrity, responsibility, high expectations, being customer driven, and valuing diversity. Performs other duties and accepts responsibilities as assigned.</p>
